## A CONVERSATION WITH | RANDALL KINNARD

Randall Kinnard is a founding partner of Nashville-based Kinnard Clavton & Beveridge, one of the top personal injury and medical negligence law firms in the country. In August, Kinnard, 66, was inducted into the Inner Circle of Advocates, an exclusive, invitation-only group composed of the top 100 trial attorneys in the country. Kinnard is the only representative from Nashville in the group, and one of only two from the state  $of\ Tennessee.\ Among\ his\ most\ notable$ cases, Kinnard recently won the largest medical malpractice case in Tennessee history, securing a \$22.2 million award on behalf of a client who went into the hospital for a broken leg and came out a paraplegic.

WHAT IS THE MOST OUTSIDE-OF-THE-BOX IDEA YOU HAVE EVER HAD IN YOUR PROFES-SIONAL CAREER? Moving our office from downtown to the suburbs in 1992. Back then, the general perception was that if you were a courthouse lawyer, your office should be downtown, near the courthouse. I believed the old saving, "Do good work and the world will beat a path to your door."

WHAT WAS THE RESULT? The number of our clients increased. Our clients, many of whom are hurt badly, have difficulty walking or are wheelchair bound, told us they appreciated parking 20 feet from our door. We did not anticipate this benefit when we made the move.

WHAT SINGLE THING MAKES YOUR ORGANI-ZATION STAND OUT? Our relationships. Just as our move indicates, we make it a priority to make our clients feel comfortable and welcome in our offices, like they're part of our team.

WHAT DOES YOUR ORGANIZATION HAVE IN THE WORKS FOR 2010? Increasing emphasis on helping children. We are in the process of founding The Children's Justice Center, a nonprofit organization which will provide free legal help, advice and court representation for abused and neglected children.

HOW DID YOU WIND UP IN YOUR CURRENT  $\textbf{POSITION?} \ I \ started \ practicing \ law \ in$ Nashville in 1977 and opened my own firm. I had no clients in my solo practice. I took small cases no other lawyers wanted. I had to try most cases because nobody had ever heard of me, and no one wanted to settle with me. I started surprising people, including myself, with some good jury verdicts.

WHAT MAKES AN EFFECTIVE BUSINESS **LEADER?** The ability to listen and being willing to suffer more than anyone else in the organization.

WHAT KEEPS YOU UP AT NIGHT? Nothing.

a hard-situation, I often ask myself, "What would Jesus do?" and the answer comes quickly. The hard part is the carrying out of that answer.

WHAT IS THERE ABOUT YOU THAT PEOPLE WOULD BE SURPRISED TO LEARN? I cry easily.

WHAT IS THE ONE BEHAVIOR OR TRAIT THAT MOST OFTEN DERAILS LEADERS' CAREERS? Dishonesty.
